WHEREAS, the Attawapiskat First Nation has an inherent right to self-government and existing Aboriginal and treaty rights throughout the whole of the Attawapiskat Traditional Homeland for the protection of all Members, and visitors to our community; and

WHEREAS, the Attawapiskat First Nation Chief and Council, and the Attawapiskat Pandemic Response Group team have been informed of a confirmed positive case of the COVID-19 corona virus in a neighbouring Mushkegowuk First Nation community; and

WHEREAS, the Attawapiskat First Nation Chief and Council, and the Attawapiskat Pandemic Response Group team out of an abundance of caution for the health and safety of Members, Residents, and guests of the Attawapiskat First Nation and in order to prevent the possible importation of the Corona virus to the community of Attawapiskat, and to assist in contact tracing have deemed certain temporary measures to be required in the interest of health and safety of all residents and guests; and

NOW THEREFORE, BE IT RESOLVED THAT the Attawapiskat First Nation Chief and Council approve and mandate that effective as of 16:00 hrs. this 15th day September, 2020 until the 29th day of September, 2020 that travel on all scheduled and chartered air flights by any airline entering Attawapiskat First Nation traditional lands for non-essential travellers be prohibited during this period to and from the community; and

BE IT FURTHER RESOLVED, that Medical Patient charters operated on behalf of the Weeneebayko Health Authority be continued during this period; however, all patients and escorts that use these flights are subject to a mandatory 14 day isolation period upon their entry to the community, and that this isolation period is also required of any additional members of their household in the same house, and to monitor themselves for the development of any symptoms related to the Covid 19 corona virus during this time; and

BE IT FURTHER RESOLVED, that cargo flights may continue to operate during this period to support the needs of the community, and flights be permitted for those essential service workers required to support the community, subject to those workers following Covid 19 corona virus protection protocols; and

BE IT FURTHER RESOLVED that the following measures are in effect until further notice:

- The wearing of masks (multi use cloth, or single use disposable) that covers the mouth and nose is now mandatory in all public spaces. This includes medical facilities, stores, corner stores, offices, schools, churches, and workplaces.
- That all community members who are not within a person's "social bubble" or household maintain a 2 meter physical separation from each other.
- That all community members stay at home as much as possible, and not to gather in social settings, or gather in groups during this time regardless of purpose.
- That all community members practice proper hand washing numerous times during the course of the day, and

BE IT FURTHER RESOLVED that a community wide curfew for those under the age of fourteen be declared in effect as of 9 each night, and that a further community wide curfew be in effect for all other ages as of midnight each night until 6 am the following morning.

BE IT FURTER RESOLVED that this Band Council Resolution remains in effect until September 29, 2020, at such time these provisions maybe reviewed.
